Texas Open Meetings Act -Personnel matters involving the appointment, employment, evaluation, Section 551.074 reassignment, duties, discipline, or dismissal of a public officer or employee or to hear a complaint against an officer or employee. 5. Texas Open Meetings Act -The deployment or specific occasion for the implementation of security Section 551.076 personnel or devices. 6. Texas Open Meetings Act -Deliberations regarding economic development negotiations.
