In accordance with Section 551.041 of the Government Code, notice is hereby given that a workshop of the City Council of the City of Three Rivers will be held on the 16TH day of November 2015, at 6:00 p.m. at City Hall, 105 N. Harborth Ave., Three Rivers, Texas 78071. The City Council may consider these agenda items up to 8:00 p.m. Any items not discussed may be tabled and brought back to the next City Council meeting for consideration and action, if any.

1. Call to order and quorum check.
2. Opening Prayer and Pledge of Allegiance to the Flag.
3. **CLOSED/EXECUTIVE SESSION:** Meet in executive session pursuant to Section 551.071 of the Texas Public Information Act to meet with its attorney to seek legal advice on a matter in which the duty of the attorney to the City Council under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Public Information Act, regarding enforcement and prosecution of zoning ordinances and ordinance prohibiting an owner or operator of truck tractors, semitrailers, pole trailers and trailers from standing, parking, storing, idling or permitting to stand, park, store or idle said vehicles on any portion of a public street, public park, public right-of-way, median, parkway, public or private school, schoolyard, church premises, or residential property within the City limits. *(Councilmember Rey Trevino)*
4. **CLOSED/EXECUTIVE SESSION:** Meet in executive session pursuant to Section 551.071 of the Texas Public Information Act to meet with its attorney to seek legal advice on a matter in which the duty of the attorney to the City Council under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Public Information Act, regarding legal processes for enforcing city ordinances. *(Councilmember Rey Trevino)*
5. **OPEN SESSION:** Consider, discuss and take action, if any, on any item discussed in Executive Session.
6. Consider and discuss City's processes for handling citizen complaints regarding ordinance violations. *(Councilmember Rey Trevino)*
7. Consider and discuss existing and possible future ordinances regarding: (1) brush; (2) high weeds; (3) litter, (4) water restrictions; and (5) junk motor vehicles. *(Mayor Sam Garcia and Councilmember Rey Trevino)*

A closed executive session may be held if the discussion of any of the above agenda items concerns one of the following:


