Harborth Ave., Three Rivers, Texas 78071. The City Council may consider these agenda items up to 9:00 p.m. Any items not discussed may be tabled and brought back to the next City Council meeting for consideration and action, if any.

1. Call to order and quorum check.
2. Opening Prayer and Pledge of Allegiance to the Flag.
3. Citizens' request on items to be placed on future agendas with time limit of two (2) minutes.
4. Consider, discuss, and take action to approve minutes for Special City Council meetings held on October 15, 2020 and October 22, 2020.
5. Consider, discuss, and take action to approve accounts payable for October 2020.
6. Consider, discuss and take action to adopt Ordinance No. 2338 to canvass the returns and declare the results of the General Election held on November 3, 2020, for the purpose of electing one Alderman for Place 1, one Alderman for Place 2, and one Alderman for Place 3.
7. Swearing In and Oath of Office for new elected city officials:
 - a. Alderman for Place No. 1
 - b. Alderman for Place No. 2
 - c. Alderman for Place No. 3
8. Consider, discuss and take action for the City Council to elect an annual Mayor Pro Tem in compliance with Section 22.037 of the Texas Local Government Code.
9. Update on operational and logistical measures related to the City's preparedness and response to the federal, state, and city's local state of emergency declaration due to a public health emergency known as COVID-19.

1. Texas Open Meetings Act - Section 551.071 Contemplated or pending litigation or matters where **legal advice** is requested of the City Attorney.
2. Texas Open Meetings Act - Section 551.072 The **purchase, exchange, lease or value or real property**, if the deliberation in an open meeting would have a detrimental effect on the position of the City in negotiations with a third person.
3. Texas Open Meetings Act - Section 551.073 A **contract for a prospective gift or donation** to the City, if the deliberation in an open meeting would have a detrimental effect on the position of the City in negotiations with a third person.
4. Texas Open Meetings Act - Section 551.074 **Personnel matters** involving the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear a complaint against an officer or employee.
5. Texas Open Meetings Act - Section 551.076 The deployment or specific occasion for the implementation of **security personnel or devices**.
6. Texas Open Meetings Act - Section 551.087 Deliberations regarding **economic development negotiations**.
